We refer to the above matter and confirm that we act for the surviving spouse Ms J.C Lumu Schmid. We are in possession of your letter and annexures to our client dated the 17th of January and 11 April 2022.

We take exception to your letters and so due to the following:

- i. ABSA has done absolutely nothing to report the estate. Our firm reported the estate and had the Master open a file. It appears that ABSA Bank wishes to have payment of the possible short fall before even reporting the estate.
- ii. Our client submit that ABSA has not done what is required of them in terms of the act as stated below and therefore requires ABSA to renunciate from the estate. Our client requires your renunciation to be in writing and to be addressed to us.

GUILLAUIME DAVID FICQ (B Proc)

- iii. Section 8 (1) of Act 66 of 1965 requires the person in possession of the will to transmit or deliver the will to the Master. Notwithstanding the deceased died the 25th of June 2021 you have not done so.
- iv. Section 9 (c) of the above Act requires you to forward the inventory to the Master.
- v. Section 51 (4) of the above act prohibits a executor to receive any renumeration before the estate has been distributed. From the paperwork provided by yourselves it is clear the short fall is to be paid into ABSA's account.
- vi. Our client submits that ABSA failed to comply with section 8 (1) and in terms of Section 102 of the above act ABSA shall be guilty of offence.

In the light of the above take note our client will not pay over to yourselves the purported short fall.
